2. Parties should make every effort to be available for the dates selected.
3. Appointment requests signed by both parties ([Optional Form PL-FL024T](#)) can be time-stamped and left in the Gibson Courthouse drop-box next to the first (1<sup>st</sup>) floor information desk or mailed to the Self-Help Center at P.O. Box 619072, Roseville, CA 95661. Mailed requests must be mailed to the court no less than 10 business days before the soonest requested appointment date.
4. Appointment requests can also be submitted electronically ([efiling portal](#)). The Court's Settlement Officer will contact **both parties** using the email addresses provided to confirm the appointment date and time and provide an electronic link to enter the video conference.
